The information provided in this application, including certificates and documents submitted, must be genuine. The Social Welfare Bureau will take legal action if there are any irregularities found, particularly:

- In accordance with "Penal Code" Article 250 (the use of false evidence) - Whoever uses false evidence or false certificate for the purpose of deceiving the public authorities, harming the interests of others, or obtaining improper benefits for themselves or the others, shall be punished with a maximum imprisonment of 1 year or a maximum fine of up to 120 days.
- In accordance with "Penal Code" Article 251 (the use of the third party's identity document) - Whoever uses the identity document issued to other parties, for having intention to harm the interests of others or this community, or obtaining improper benefits for themselves or the others, shall be punished with a maximum imprisonment of 3 years or a fine.
